

STATEMENT OF WORK

These deliverables apply to this individual practice. For other planned practice deliverables refer to those specific Statements of Work.

DESIGN**Deliverables:**

1. Design documents that demonstrate criteria in Florida NRCS practice standard have been met and are compatible with planned and applied practices
 - a. Practice purpose(s) as identified in the conservation plan.
 - b. List of required permits to be obtained by the client
 - c. List of facilitating practice
 - d. Practice standard criteria-related computations and analyses to develop plans and specifications including but not limited to:
 - i. Acres of the field
 - ii. Number and width of strips
 - iii. Minimum and maximum row grade for tilled strips (for sheet and rill erosion)
 - iv. Alignment, orientation and width of strips (for wind erosion)
 - v. Vegetative cover planned
 - vi. Results of NRCS-approved erosion prediction tools or equivalent (RUSLE2 and WEQ)
2. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describes the requirements to apply the practice and obtain necessary permits. Plans and specifications shall be developed in accordance with the requirements of conservation practice standard Stripcropping (Code 585).
3. Operation and maintenance plan
4. Certification that the design meets practice standard criteria and comply with applicable laws and regulations
5. Design modifications during installation as required

INSTALLATION**Deliverables**

1. Pre-application conference with client
2. Verification that client has obtained required permits
3. Staking and layout according to plans and specifications including applicable layout notes
4. Application guidance as needed
5. Facilitate and implement required design modifications with client and original designer
6. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation
7. Certification that the application process and materials meets design and permit requirements

CHECK OUT**Deliverables / Practice Certification and Check-out Requirements**

1. Records of application
 - a. Number and width of strips
 - b. Actual row grade applied (for sheet and rill erosion) or strip orientation (for wind erosion)
 - c. Acres of the field applied
 - d. Water and Wind erosion prediction results (RUSLE2 and WEQ)
 - e. Vegetative cover applied
2. Certification that the application meets Florida NRCS standards and specifications and is in compliance with permits
3. Progress reporting
