

STATEMENT OF WORK

These deliverables apply to this individual practice. For other planned practice deliverables refer to those specific Statements of Work.

DESIGN

Deliverables

All design documents shall be developed in accordance with the requirements of the [NRCS Hawaii Field Office Technical Guide \(eFOTG\)](#), Section IV, Conservation Practice Standard and Conservation Practice Specification.

1. Design documents that demonstrate criteria in practice standard have been met and are compatible with planned and applied practices.
 - a. Practice purpose(s) as identified in the conservation plan.
 - b. List of required permits to be obtained by the client.
 - c. Practice standard criteria related computations and analyses to develop plans and specifications including but not limited to:
 - i. Required seedbed condition and preparation methods.
 - ii. Soil and seed amendments needed.
 - iii. Variety or origin and amount of each species to be planted.
 - iv. Planting dates and depths and description of planting equipment.
 - v. Instructions as needed for placing different seed types (i.e. fluffy, large, small, slick and dense) in suitable drill boxes.
2. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describes the requirements to install the practice and obtain necessary permits.
3. Specification sheet provided to the client that adequately describes the requirements to apply the practice and obtain necessary permits. *The [NRCS Hawaii Field Office Technical Guide \(eFOTG\)](#) Section IV, Jobsheet for the practice shall be completed and used to provide the client with requirements to install the practice.*
4. Identify fields where practice to be applied on a farm or ranch plan map.
5. Operation and Maintenance Plan. *The [NRCS Hawaii Field Office Technical Guide \(eFOTG\)](#) Section IV, Jobsheet for the practice shall be completed and used to provide the client with requirements for the operation and maintenance of the practice.*
6. Certification that the design meets practice standard criteria and comply with applicable laws and regulations.
7. Design modifications during installation as required.

INSTALLATION

Deliverables

1. Pre-application conference with client and contractor.
2. Verification that client has obtained required permits.
3. Staking and layout according to plans and specifications including applicable layout notes.
4. Application inspection.
 - a. Actual materials used.
 - b. Inspection records.
5. Facilitate and implement required design modifications with client and original designer
6. Advise client/NRCS on compliance issues with all federal, state, and local laws, regulations and NRCS policies during installation.
7. Certification that the application process and materials meets design and permit requirements.
