DESIGN

Deliverables

1. Design documentation that will demonstrate that the criteria in the Natural Resources Conservation Service (NRCS) practice standard has been met and is compatible with other planned and applied practices.
2. Practice purpose(s) as identified in the conservation plan
3. List of required permits to be obtained by the client
4. List of facilitating practices
5. Practice standard criteria-related computations and analyses to develop plans and specifications including but not limited to the following:
 - a. Resource inventories
 - b. Identification of wildlife-targeted species and habitat requirements
 - c. Grazing plans
 - d. Drought plans
6. Operation and maintenance plan
7. Written plans and specifications (including sketches and drawings) shall be provided to the client that adequately describes the requirements to install the practice and obtain necessary permits.
8. Certifications that the design meets practice standard criteria and complies with applicable laws and regulations
9. Design modifications during installation as required.
10. Document seeding and planting of grass and forb species on Form KS-ECS-4, Grass Seeding, and Form KS-ECS-5, Tree/Shrub Planting.
11. Document environmental concerns on Form KS-CPA-52, Environmental Effects for Conservation Planning.

INSTALLATION

Deliverables

1. Pre-application conference with client
2. Verification that client has obtained required permits
3. Application guidance as needed
4. Facilitate and implement required design modifications with client and original designer.
5. Certification that the application process and materials meet plan and permit requirements
6. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations, and NRCS policies during installation.
7. Certification that the application processes and materials meet design and permit requirements
8. Ensure seeding, planting, and management is according to the Field Office Technical Guide standards.

CHECKOUT

Deliverables

1. Records of application
 - Extent of practice units applied
2. Certification that the installation meets NRCS standards and specifications on Form KS-ECS-4 and Form KS-ECS-5, and is in compliance with permits
3. Progress reporting
