

**STATEMENT OF WORK**

## **DESIGN**

---

### **Deliverables:**

1. Design documents that demonstrate criteria in NRCS practice standard have been met and are compatible with planned and applied practices.
  - a. Practice purpose(s) as identified in the conservation plan
  - b. List of required permits to be obtained by the client or list of records required to be kept by the client
  - c. Practice standard criteria-related computations and analyses to develop plans and specifications including but not limited to:
    - i. Identification of targeted species
    - ii. Control methods (e.g. biological, cultural, chemical, mechanical)
    - iii. Environmental risk assessment of planned control method
    - iv. Mitigation techniques, if necessary
    - v. Location of sensitive resources and setbacks, if applicable
    - vi. Scouting Plan and threshold levels if applicable
    - vii. List of prevention and avoidance strategies to be implemented
    - viii. Crop specific IPM plan
2. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describes the requirements to install the practice and obtain necessary permits. Plans and specifications shall be developed in accordance with the requirements of the current conservation practice standard Integrated Pest Management (Code 595).
3. Documentation of needed operation and maintenance.
4. Certification that the design meets practice standard criteria and comply with applicable laws and regulations.
5. Design modifications during installation as required.
6. Records shall be kept that include the results and impacts of scouting reports, and where and when each pest prevention, avoidance, and suppression technique was implemented along with any identified risks and their associated mitigating activities.

## **INSTALLATION**

---

### **Deliverables**

1. Pre-application conference with client.
2. Verification that client has obtained required permits.
3. Layout and communication of setback requirements for wetlands, water bodies, streams and other pest control-sensitive areas.
4. Application guidance as needed.
5. Facilitate and implement required design modifications with client and original designer.
6. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation.
7. Certification that the application process and materials meet design and permit requirements.

## **CHECK OUT**

---

### **Deliverables**

1. Records of application.
  - a. Extent of practice units applied
  - b. Actual materials/control method/mitigation techniques used
  - c. Application rate, method and timing
2. Certification that the application meets NRCS standards and specifications and is in compliance with permits.
3. Progress reporting.
