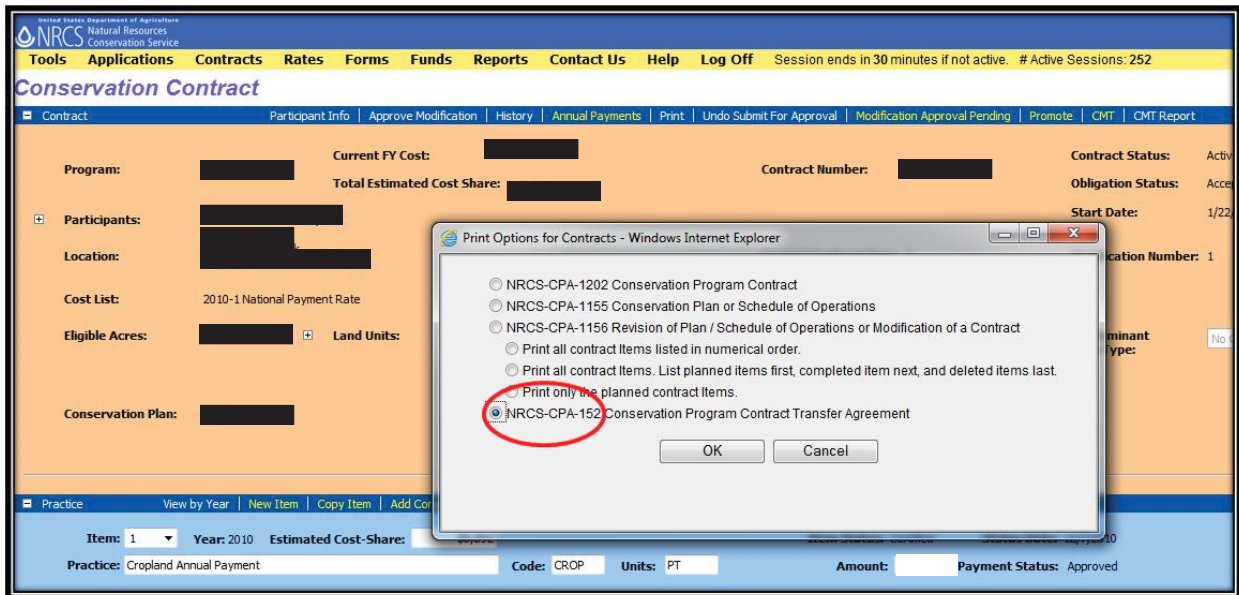


NRCS-CPA-152 Conservation Program Contract Transfer Agreement is only available through Protracts:

When you do a transfer modification in protracts, the form will automatically generate. Print it the same way you do a normal modification. The only time we will need a manually printed form is if FSA changes the name of a participant in SCIMS (does not add a new record for an SCIMS participant).
