Re: Transmit County-level Climatic Information; Lesser Prairie Chicken Biological Opinion, Conservation Measures, Flow Chart and Crucial Habitat Assessment Tool (CHAT); Colorado Working Lands for Wildlife Implementation Plan; and cancel obsolete CO-ECS-05 worksheets

This Technical Guide Notice transmits the following materials to the Colorado electronic Field Office Technical Guide (FOTG).

<u>Using the WETS Table</u>. Provides a hyperlink to the NRCS National Water and Climate Center's website on "WETS Table Documentation".

WETS tables are available in Section II under Climate Data, County Level Climate Data, by selecting the <u>Agricultural Applied Climate Information System (AgACIS)</u> link. The Office ID number is the local FIPS Code.

The objective of the WETS Table is to define the normal range for monthly precipitation and normal range for growing season required to assess the climatic characteristics for a geographic area over a representative time period.

## Section II, Special Environmental Concerns, Threatened and Endangered Species, ESA Programmatic Consultation

LPC Biological Opinion. New Content. On 09/14/2014 the NRCS and the U.S. Fish and Wildlife Service formalized the "U.S. Fish and Wildlife Service's Biological Opinion for the Natural Resources Conservation Service's Lesser Prairie-Chicken (LPC) Initiative and Associated Procedures, Conservation Practices, and Conservation Measures." (aka LPC Biological Opinion). This document replaces the LPC Conference Opinion, 11/22/2013.

Conservation planning occurring within LPC potential habitat will follow the conservation measures as outlined in the Opinion. GM\_190\_410\_410.22

<u>LPC Conservation Measures</u>. New Content. Provides an excerpt of the LPC Biological Opinion's conservation measures, <u>including state-specific criteria</u>.

LPC Flow Chart. New Content. Provides an excerpt of the flowchart provided in the LPC Biological Opinion (Appendix VII), in a fillable .pdf format. This flowchart demonstrates when the LPC Biological Opinion would apply.

LPC Crucial Habitat Assessment Tool (CHAT) – New content. An online mapping application to provide information on lesser prairie-chicken habitat. For NRCS planning purposes, CHAT will be used for: targeting conservation efforts for the Lesser Prairie Chicken Initiative (LPCI); helping to determine when the NRCS' LPCI Biological Opinion conservation measures apply (defined the Action Area); and for CRP conservation planning to ensure compliance with the provisions of FSA' LPC Biological Opinion.

<u>CO's WLFW Implementation Plan</u>. New Content. The WLFW implementation plan was relayed previously as state policy in Bulletin CO-300-14-9. Changes: reference to the lesser prairie-chicken conference opinion have been replaced with the biological opinion.
