<u>WCC Job Approval Authority</u>. Revision. The JAA roster will provide a current list of qualified NRCS employees (WCC agency experts) who have demonstrated the knowledge and skills necessary to conduct the various tasks of wetland conservation compliance. The revision includes updated employee JAA.

Section III, Legislated Programs, Wetland Conservation Compliance

WCC CO-CPA-32, Remote Sensing. New. Colorado form to review and document Food Security Act, Wetland Conservation Compliance wetland hydrology from remote sources. This approach uses protocol from National Food Security Act Manual (NFSAM), fifth edition, Part 527 (Circular 6, Dec. 2010) and the 1987 U.S. Army Corps of Engineers Wetland Delineation (Corps Manual), Part IV, with the use of the regional supplements.

Specifically, this form is used with NRCS Part 650, National Engineering Handbook, Chapter 19 - Hydrology Tools for Wetland Identification and Analysis (210–VI–NEH, September 2015), Part 650.1911 – Remote Sensing Applications.
