DESIGN**Deliverables:**

1. Design documents that demonstrate criteria in Florida NRCS practice standard have been met and are compatible with planned and applied practices
 - a. Practice purpose(s) as identified in the conservation plan.
 - b. List of required permits to be obtained by the client
 - c. List all required and/or facilitating practices
 - d. Compliance with NRCS national and state utility safety policy (NEM part 503-Safety, Section 503.00 through 503.22)
 - e. Practice standard criteria-related computations and analyses to develop plans and specifications including but not limited to:
 - i. Soil moisture at time of tillage
 - ii. Required tillage depth
 - iii. Soil contaminant inhibiting crop growth.
 - iv. Performed on or near contour on all sloping soils
2. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describes the requirements to apply the practice and obtain necessary permits. Plans and specifications shall be developed in accordance with the requirements of Florida NRCS conservation practice standard Deep Tillage (Code 324).
3. Operation and maintenance plan
4. Certification that the design meets practice standard criteria and comply with applicable laws and regulations
5. Design modifications during application as required

INSTALLATION**Deliverables**

1. Pre-application conference with client
2. Verification that client has obtained required permits
3. Application guidance as needed
4. Facilitate and implement required design modifications with client and original designer
5. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during application
6. Certification that the application process and materials meets design and permit requirements
