

STATEMENT OF WORK

DESIGN

Deliverables

1. Design documents that demonstrate criteria in Florida NRCS practice standard have been met and are compatible with planned and applied practices
 - a. Practice purpose(s) as identified in the conservation plan.
 - b. List of required permits to be obtained by the client.
 - c. Compliance with NRCS national and state utility safety policy (NEM Part 503-Safety, Subpart A ÷ Engineering Activities Affecting Utilities 503.00 through 503.06).
 - d. Practice standard criteria related computations and analyses to develop plans and specifications including but not limited to:
 - i. Florida Supplement, National Engineering Field Handbook (NEFH), Part 650, Chapter 1
 - ii. Surface Drainage
 - iii. Field grades
 - iv. Structural, Mechanical and Appurtenances
 - v. Soil Characteristics (e.g. texture, permeability, and depth)
 - vi. Erosion Control
2. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describes the requirements to install the practice and obtain necessary permits (Florida Supplement, NEFH, Part 650, Chapter 1).
3. Design Report per NEM Part 511, Subpart B ÷ Documentation, 511.11.
4. Quality Assurance Plan (QAP) as per NEM Part 512, Subpart D Quality Assurance Activities.
5. Operation and Maintenance Plan as per NRCS National Operation and Maintenance, Part 500, Subpart D.
6. Certification that the design meets practice standard criteria and comply with applicable laws, rules, and regulations (NEM Subpart A, 505.03 (b) (2) and Florida Supplement, NEFH, Part 650, Chapter 1)
7. Design modifications during installation as required.

INSTALLATION

Deliverables

1. Pre-construction conference with client and contractor and signed form FL-ENG-40.
2. Verification that client has obtained required permits.
3. Staking and layout according to plans and specifications including applicable layout notes.
4. Installation inspection (according to inspection plan as appropriate).
 - a. Actual materials used (Part 512, Subpart D ÷ Quality Assurance Activities, 512.33)
 - b. Inspection records.

5. Facilitate and implement required design modifications with client and original designer.
6. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation.
7. Certification that the installation process and materials meets design and permit requirements.

CHECK OUT

Deliverables

1. Check out notes as specified in the Florida Supplement, NEFH, Part 650, Chapter 1
2. As-built documentation
 - a. Extent of practice units applied
 - b. Drawings
 - c. Final quantities
3. Certification that the installation meets NRCS standards and specifications and is in compliance with permits, NEM Part 505 – Non NRCS Engineering Services, Subpart A.
4. Progress reporting.
