

STATEMENT OF WORK
Integrated Pest Management (595)
Illinois

These deliverables apply to this individual practice. For other planned practice deliverables refer to those specific Statements of Work.

DESIGN**Deliverables:**

1. Design documents that demonstrate criteria in NRCS practice standard have been met and are compatible with planned and applied practices.
 - a. Practice purpose(s) as identified in the conservation plan
 - b. List of required permits to be obtained by the client
 - c. Practice standard criteria-related computations and analyses to develop plans and specifications including but not limited to:
 - i. Identification of targeted species
 - ii. Control methods (e.g. biological, cultural, chemical, mechanical)
 - iii. Environmental risk assessment (WIN_PST) of planned control method
 - iv. Mitigation techniques, if necessary
 - v. Location of sensitive resources and setbacks, if applicable
 - vi. Scouting and Monitoring Protocols used and threshold levels applicable to the targeted pest species.
 - vii. List of prevention and avoidance strategies to be implemented
2. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describes the requirements to install the practice and obtain necessary permits. Plans and specifications shall be developed in accordance with the requirements of conservation practice standard Integrated Pest Management (Code 595) Job Sheet.
3. Documentation of needed operation and maintenance.
4. Certification that the design meets practice standard criteria and comply with applicable laws and regulations.
5. Design modifications during implementation as required.
6. Records shall be kept that include scouting reports, location, and specifics of pest suppression techniques used.

INSTALLATION**Deliverables**

1. Pre-application conference with client.
2. Verification that client has obtained required permits.
3. Communication of setback requirements for wetlands, water bodies, streams and other pest control-sensitive areas.
4. Application guidance as needed.
5. Facilitate and implement required design modifications with client and original designer.
6. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation.
7. Certification that the application process and materials meet design and permit requirements.

CHECK OUT**Deliverables**

1. Records of application.
 - a. Extent of practice units applied
 - b. Actual materials/control method/mitigation techniques used are to be certified by landowner, operator and/or Technical Service Provider on an Illinois Integrated Pest Management (595) Job Sheet or other approved forms approved by NRCS.
 - c. Application rate, method and timing of pest control measures. Documentation must indicate location of practice implementation.
2. Certification that the application meets NRCS standards and specifications and is in compliance with permits.
3. Progress reporting.
