

STATEMENT OF WORK
Riparian Forest Buffer (391)
North Carolina

These deliverables apply to this individual practice. For other planned practice deliverables, refer to those specific Statements of Work.

DESIGN

Deliverables

1. Design documents that comply with the purpose of the practice selected by the decision-maker and the applicable criteria in the NRCS practice standard and are compatible with other planned and applied practices.
 - a. Practice purpose(s) as identified in the conservation plan.
 - b. List of required permits to be obtained by the client.
 - c. Practice standard criteria-related computations and analyses to develop plans and specifications including but not limited to:
 - i. Determination of buffer zone widths and lengths and adapted species of woody plants to be planted, retained, and/or naturally reestablished in applicable zones.
 - ii. Protective measures for planted stock including use exclusion.
 - iii. Additional provisions, as required, for reducing excess amounts of pollutants in surface runoff and shallow ground water flow (creation of a zone 2 and a zone 3); providing habitat for aquatic organisms and terrestrial wildlife; and increasing carbon storage in biomass and soils.
2. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describe the requirements to install the practice and obtain necessary permits (refer to OPERATION AND MAINTENANCE section of the practice standard).
3. Documentation of needed operation and maintenance (refer to PLANS AND SPECIFICATIONS section of the practice standard).
4. Certification that the design meets practice standard criteria and complies with applicable laws and regulations.
5. Design modifications during installation as required.

INSTALLATION

Deliverables

1. Pre-application conference with client.
2. Verification that client has obtained required permits.
3. Staking and layout according to plans and specifications, including applicable layout notes.
4. Application guidance as needed.
5. Facilitate and implement required design modifications with client and original designer.
6. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation.
7. Certification that the application process and materials meet design and permit requirements.

CHECK OUT

Deliverables

1. Records of application:
 - a. Extent of practice units applied.
 - b. Width and extent of buffer zones.
 - c. Actual plant materials used and protective measures.
 - d. 'As Built/Installed' drawings/maps for client as appropriate.
2. Certification that the application meets NRCS standards and specifications and is in compliance with permits.
3. Progress reporting.
