



Animal Enhancement Activity – ANM31 – Drainage water management

State Criteria (same as NATIONAL CRITERIA)

Cropland in perennial vegetation which is hayed is eligible for this enhancement provided that drainage features exist (i.e. ditch, tile, etc.) and are temporarily plugged to facilitate flooding. Removal of pumping to allow fields to flood is not an acceptable measure to qualify for this enhancement.

Additional Criteria for Nebraska

The wildlife management objectives for most drainage water management plans using this enhancement will include one or more of the following groups of targeted wildlife species:

- Waterfowl and Water Birds – including species such as mallard, blue-winged teal, Northern pintail, great blue heron, King rail, etc.
- Shorebirds – including species such as buff-breasted and other sandpiper species, American avocet, etc.
- Amphibians – including species such as Northern leopard frog, Blanding’s turtle, etc.

Assistance from a qualified wildlife biologist or NRCS staff with adequate job approval authority for wildlife habitat is required to conduct the habitat inventory and develop the management plan for the target species, including any ponding and drawdown periods. An [NE-CPA-14](#) Wildlife Development/Management Plan may be used to document these items.
