Low risk pesticide with crop rotation of 2 crop types and spot spray or banding method

Payment = \$4.00 / Acre / Year to apply Integrated Pest Management principles with low risk pesticides and a crop rotation consisting of a high residue crop following a low residue crop (minimum diversity of two crop types with no low residue crops following low residue crops).

Enhancements activities refer to actions that provide resource benefits beyond the level prescribed by the Natural Resources Conservation Service (NRCS) Conservation Practice Standards. Once implemented, enhancement activities should result in an observable or measurable improvement to the condition of one or more of the soil, water, air, plant or animal resources, or provide for more efficient resource utilization and/or energy conservation.

Crop scouting with treatment thresholds determined prior to treatment is required. Pest management record history will be maintained. **Only situations with intermediate, low, or very low risk of loss from leaching and runoff are allowed (i.e., WinPST soil/pesticide interaction analysis conducted). All pesticides applied by band method or spot spraying.** Crop rotation consist of a with a high residue crop following a low residue crop (minimum diversity of two crop types with no low residue crops following low residue crops)

Documentation Required: Farmer or crop consultant certification of WIN-PST risk rating and a crop rotation consisting of a high residue crop following a low residue crop (minimum diversity of two crop types with no low residue crops following low residue crops). An example is provided to assist you.
