

New Mexico EQIP 2016 Payment Schedule for Conservation Practices

Note: Payments are calculated by multiplying the unit cost by the amount of the units of the component (scenario). The component selected is the one that addresses the resource concern at the least cost to the government.

The full name for the unit types is found on page 37.

The unit cost is a fraction of a regional average of the cost to install a typical scenario of the practice component. The scenario description that describes how the cost is estimated is found in eFOTG, Section 1, Cost Data.

Payment components beginning with "HU" are higher payment rates for historically underserved program participants. Limited Resource Farmers/Ranchers and Socially Disadvantaged Farmers/Ranchers receive 90% of the estimated cost of the typical scenario. All other farmers and ranchers receive 75% of the estimated cost. The unit cost factors in these percentages.
