401.34 State Supplements

This section is reserved for State Conservationists to add any required state or tribal laws or regulations which may affect how cultural resources are considered during the planning of agency undertakings. Below is the list of undertakings subject to consultation in the state of New Mexico. Field Offices should adhere to this list when developing their conservation plans.

Appendix A

Undertakings Subject to Consultation

For the purposes of this Agreement, the signatories agree that the following practices shall be considered undertakings subject to standard consultation under the listed conditions. Exemptions to standard consultation include all undertakings that normally have the potential to affect, but under the conditions specified below, the effects are foreseeable, likely to be minimal, and not to be adverse. These are exempted from standard consultation. For example, conditions that includes undertakings that will not go beyond the depth or extent of previous disturbance, or will not involve replacement of structures older than 50 years. Routine maintenance of existing structures will be considered an exemption for the purpose of this agreement. All exemptions listed in the National Agreement shall be applicable in this agreement. Any additional exemptions may be added by mutual agreement with the signatories.
