

STATEMENT OF WORK
Pasture and Hay Planting (512)

These deliverables apply to this individual practice. For other planned practice deliverables refer to those specific Statements of Work.

Items marked with an asterisk (*) will be delivered to the Designated Conservationist.

DESIGN

Deliverables:

1. Design documents that demonstrate criteria in practice standard have been met and are compatible with planned and applied practices.
 - a. Practice purpose(s) as identified in the conservation plan
 - b. List of required permits to be obtained by the client
 - c. Practice standard criteria related computations and analyses to develop plans and specifications including but not limited to:
 - i. Required seedbed condition and preparation methods
 - ii. Soil and seed amendments needed
 - iii. Variety or origin and amount of each species to be planted
 - iv. Planting dates and depths and description of planting equipment
 - v. Instructions as needed for placing different seed types (i.e. fluffy, large, small, slick and dense) in suitable drill boxes
2. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describes the requirements to install the practice and obtain necessary permits.
3. ***Operation and maintenance plan.**
4. ***In cases where the practice location has changed, a statement to NRCS notifying the agency of the change in location as well as a map showing the new practice location. The statement will include the landowner's name, program name, contract number and practice name.**
5. ***Signed *Warranty of Technical Services Provided* form indicating compliance with practice standard criteria and applicable laws and regulations**
6. Design modifications during installation as required.

INSTALLATION

Deliverables

1. Delay of installation until TSP receives written verification from NRCS that all NEPA requirements have been satisfied for this practice
2. Pre-application conference with client and contractor
3. Verification that client has obtained required permits
4. Staking and layout according to plans and specifications including applicable layout notes
5. Identify fields where practice to be applied on a farm or ranch plan map.
6. Application inspection:
 - a. Actual materials used
 - b. Inspection records
7. Facilitate and implement required design modifications with client and original designer
8. ***Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation**
9. ***Signed *Warranty of Technical Services Provided* form indicating compliance with practice standard criteria and applicable laws and regulations**
