**Deliverables:**

1. Documentation that will demonstrate that the criteria in NRCS practice standard have been met and are compatible with other planned and applied practices.
  - a. Practice purpose(s) as identified in the conservation plan
  - b. List of required permits to be obtained by the client
  - c. Compliance with NRCS national and state utility safety policy (NEM Part 503-Safety, Subpart A - Engineering Activities Affecting Utilities 503.00 through 503.06)
  - d. Practice standard criteria related computations and analyses to develop plans and specifications including but not limited to:
    - i. Location/Alignment
    - ii. Height
    - iii. Size
    - iv. Spacing
    - v. Type of material
2. Job sheets or written plans and specifications including sketches and drawings shall be provided to the client that adequately describes the requirements to install the practice and obtain necessary permits.
3. Identify the fields where the practice is to be applied on a farm or ranch plan map.
4. Operation and Maintenance Plan.
5. Certification that the design meets practice standard criteria and comply with applicable laws and regulations.
6. Modifications during installation as required.

**Deliverables**

1. Pre Installation conference with client and contractor.
2. Verification that client has obtained required permits.
3. Installation inspection (according to inspection plan as appropriate).
  - a. Actual materials used (Part 512, Subchapter D Quality Assurance Activities, 512.33)
  - b. Inspection records
4. Facilitate and implement required design modifications with client and original planner.
5. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation.
6. Certification that the installation process and materials meets design and permit requirements.

**Deliverables**

1. As-Built documentation on the job sheet or plan map in red .
  - a. Extent of practice units applied
  - b. Final quantities
2. Certification that the installation meets NRCS standards and specifications and is in compliance with permits.
3. Progress reporting.
