

STATEMENT OF WORK
Fuel Break (383)
Oklahoma

These deliverables apply to this individual practice. For other planned practice deliverables refer to those specific Statements of Work.

DESIGN

Deliverables:

1. Design documents that demonstrate criteria in NRCS practice standard have been met and are compatible with planned and applied practices.
 - a. Practice purpose(s) as identified in the conservation plan
 - b. List of required permits to be obtained by the client
 - c. Practice standard criteria-related computations and analyses to develop plans and specifications including but not limited to:
 - i. Width, length and location of the fuel break including condition and extent of remaining vegetation
 - ii. Residual forest overstory stocking/spacing if applicable including ladder fuel treatment
 - iii. Extent and timing of slash treatment (coordinated with Oklahoma NRCS Woody Residue Treatment – 384 standard)
 - iv. Treatment of fine fuels (grass and forbs) if applicable
 - v. Establishment of fire-resistant vegetation if applicable
2. Written plans and specifications including sketches and drawings shall be provided to the client to adequately describe the requirements to install the practice and obtain necessary permits.
3. Documentation of needed operation and maintenance.
4. Certification that the design meets practice standard criteria and comply with applicable laws and regulations.
5. Design modifications during installation as required.

INSTALLATION

Deliverables

1. Pre-application conference with client.
2. Verification that client has obtained required permits.
3. Layout and, as applicable, sample marking of overstory 'leave' trees or 'take' trees according to plans and specifications including applicable layout notes.
4. Application guidance as needed.
5. Facilitate and implement required design modifications with client and original designer.
6. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation.
7. Certification that the application process and materials meet design and permit requirements.

CHECK OUT

Deliverables

1. Records of application.
 - a. Extent of practice units applied
 - b. Type of vegetation treated
 - c. Width
 - d. Length
 - e. Slope percent
 - f. Separation distance between crowns
 - g. Separation distance between shrubs
2. Certification that the application meets NRCS standards and specifications and is in compliance with permits.
3. Progress reporting.
