

## STATEMENT OF WORK Prescribed Forestry (409) West Virginia

These deliverables apply to this individual practice. For other planned practice deliverables refer to those specific Statements of Work.

### DESIGN

---

#### Deliverables:

1. Design documents that demonstrate criteria in NRCS practice standard have been met and are compatible with planned and applied practices.
  - a. Practice purpose(s) as identified in the conservation plan
  - b. List of required permits to be obtained by the client
  - c. Practice standard criteria-related computations and analyses to develop plans and specifications including but not limited to:
    - i. An inventory of the existing forest condition and a description of desired forest condition.
    - ii. A prescription developed for a minimum management period of 10 years.
    - iii. Describe and give rationale for selection of silvicultural system including ecological and economic considerations.
    - iv. Compliance with applicable federal, state and local laws and regulations during the installation, operation and maintenance of this practice. See Field Office Technical Guide Reference - Best Management Practices for Controlling Soil Erosion and Sedimentation from Logging Operations in West Virginia
    - iv. Determination of the harvest-regeneration strategy and the species of tree and understory vegetation to be retained
    - v. Timing and method of removal for trees and understory to be eliminated, if applicable
    - vi. Mitigation of wildfire hazard, erosion, runoff, soil compaction and soil displacement to acceptable levels
2. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describe the requirements to install the practice and obtain necessary permits.
3. Documentation of needed operation and maintenance.
4. Certification that the design meets practice standard criteria and comply with applicable laws and regulations.
5. Design modifications during installation as required.

**Note:** Design of practice will be in compliance with practice standard and applicable criteria for the appropriate purpose(s). Practice specification will include the information listed in the "Plans and Specifications" and "Operation and Maintenance" section of the conservation practice standard. The design will document the client's decisions using a narrative and/or attachments.

### INSTALLATION

---

#### Deliverables

1. Pre-application conference with client.
2. Verification that client has obtained required permits.
3. Layout and, as applicable, according to plans and specifications including applicable layout notes.
4. Application guidance as needed.
5. Facilitate and implement required design modifications with client and original designer.
6. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation.
7. Certification that the application process and materials meet design and permit requirements.

**Note:** Provide written documentation of any modification of the approved design. Certify that the modification meets practice standard on appropriate NRCS form and/or letter of certification as applicable. At a minimum, documentation will include quantities and amounts. The location of the applied practice will be identified on the conservation plan map for non-structural practices.

### CHECK OUT

---

#### Deliverables

1. Records of application.
  - a. Extent of practice units applied
  - b. Actual mitigation measures used and applied
2. Certification that the application meets NRCS standards and specifications and is in compliance with permits.
3. Progress reporting.

**Note:** Meet with client to review practice operation and maintenance. Certify the conservation practice has been installed according to practice design and specifications using a letter of certification or appropriate NRCS form.
