

STATEMENT OF WORK

These deliverables apply to this individual practice. For other planned practice deliverables refer to those specific Statements of Work.

DESIGN

Deliverables:

1. Design Surveys
 - a. Topography as needed
 - b. Any limiting or controlling ground or water surface elevations
 - c. Soil investigations needed for sealant design
2. Design documents that demonstrate criteria in practice standard have been met and are compatible with planned and applied practices
 - a. Practice purpose(s) as identified in the conservation plan.
 - b. List of required permits to be obtained by the client
 - c. Compliance with NRCS national and state utility safety policy (NEM part 503-Safety, Section 503.00 through 503.22)
 - d. Practice standard criteria related computations and analyses to develop plans and specifications including but not limited to:
 - i. Catchment area (watershed)
 - ii. Yield computations
 - iii. Soil sealant design if considered or used
 - iv. Catchment surface materials design if considered or used
 - v. Capacity
 - vi. Water requirements
 - vii. Overflow Protection
 - viii. Materials
 - ix. Fencing requirements
 - x. Climatic Considerations (e.g. evaporation, freezing)
 - xi. Quantity computations
3. Written plans and specifications including sketches and drawings shall be provided to the client that adequately describes the requirements to install the practice and obtain necessary permits.
4. Operation and maintenance plan
5. Certification that the design meets practice standard criteria and comply with applicable laws and regulations (NEM Subpart A, 505.03(b) (2)).
6. Design modifications during installation as required

INSTALLATION

Deliverables

1. Pre-installation conference with client and contractor
2. Verification that client has obtained required permits
3. Staking and layout according to plans and specifications including applicable layout notes
 - a. Alignment and grade staking
4. Installation inspection
 - a. Actual materials used
 - b. Inspection records
5. Facilitate and implement required design modifications with client and original designer
6. Advise client/NRCS on compliance issues with all federal, state, tribal, and local laws, regulations and NRCS policies during installation
7. Certification that the installation process and materials meets design and permit requirements (NEM Subpart A, 505.03(c) (1)).
